

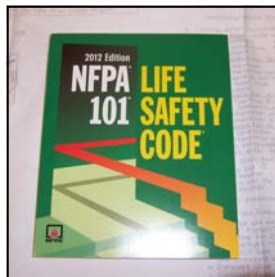
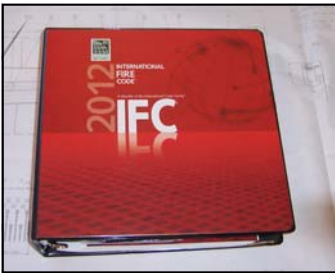
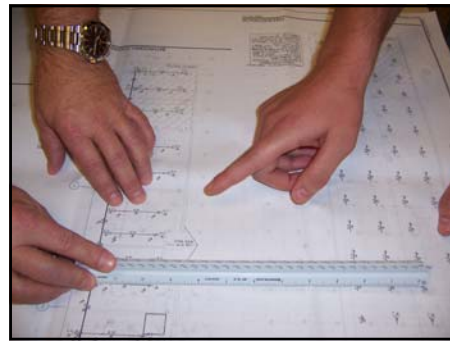

- FSCI retains the right to extend the review time on large projects for quality assurance.
